**THE FOLLOWING OUTLINES THE TERMS & CONDITIONS OF MEMBERSHIP AT THE CROATIAN SPORTING CLUB PORT LINCOLN INCORPORATED.**

**Membership Fees:**

Upon receipt of the Membership Fee, you are registered as a Member of the Croatian Sporting Club Port Lincoln Incorporated. Membership Fees are payable in advance annually (financial year, July to June), with rates for the different Types of Membership approved by the Management Committee. No concession rebate is available.

**Changing Membership Details:**

Only the named Member or person authorised in writing by the named Member may request a change in Membership details.

**Cancellation of Membership:**

A Member may cancel their Membership at any time by providing either verbal or written notification to the Croatian Sporting Club Port Lincoln Incorporated, provided both the person making the request and the Membership concerned can be positively verified.

**Refund Policy:**

The Croatian Sporting Club Port Lincoln Incorporated does not give refunds on Membership Fees.

**Lapsing of Membership:**

Any Member who does not pay their Membership Fee by the end of financial year will not be entitled to access benefits and entitlements of Membership for the following year.

**Voting Rights:**

All Foundation, Family and Single Members have the right to vote at the Annual General Meeting (AGM) of the Croatian Sporting Club of Port Lincoln Incorporated, provided they have paid their Membership Fee for that financial year. Any Foundation, Family or Single Member who has not fulfilled payment for the financial year, will not have the right to vote at the upcoming Annual General Meeting (AGM).
